Foreword

The International Commission for Uniform Methods of Sugar Analysis Ltd. (ICUMSA®), the only international organisation concerned solely with analytical methods for the sugar industry, was founded in 1897 and is thus one of the first international standards organisations like ISO/IEC, CODEX Alimentarius, AOAC and others.

The development and standardisation of analytical methods for sugar industries, their suppliers and their customers are done by voluntary members in more than 20 National Committees worldwide.

ICUMSA® Methods are published as well in printed as in electronic form. While the complete Methods Book is available both as print, time-limited and regularly updated electronic version the individual methods are only offered as time-limited online version. The print version is updated by publication of Supplements regularly. All versions (print and electronic) are copyright protected by the applicable national copyright laws according to international rules.

At the same time, the aim of ICUMSA® is to have their methods used by everybody involved in production, trade, application and quality control of sugar, including raw materials and by products, worldwide.

This document explains, how to use and how to cite ICUMSA® Methods respecting copyright laws and ICUMSA® trademark rights.

1. Intellectual Property (according to WIPO definitions)

Copyright

Copyright (or author's right) is a legal term used to describe the rights that creators have over their literary, more generally written and artistic works. Works covered by copyright range from books of any content, including scientific and technical works, music, paintings, sculpture, and films, to computer programs, databases, advertisements, maps, and technical drawings.

Copyright law aims to balance the interests of those who create content, with the public interest in having the widest possible access to that content.

Trademark

A trademark is a sign capable of distinguishing the goods or services of one enterprise from those of other enterprises. Trademarks are protected by intellectual property rights. The name ICUMSA® is protected in many countries of the world.

2. Citation

"Citation" means telling your readers that certain material in your work came from another source. ICUMSA® Methods should be cited as follows:

Method number (Year of last revision) Title – Status (Official (Reference) or Tentative or Accepted), Verlag Dr. Albert Bartens KG, Berlin, Germany

For example:

ICUMSA® Method GS1-1 (2011) The Determination of the Polarisation of Raw Sugar by Polarimetry – Official, Verlag Dr. Albert Bartens KG, Berlin, Germany

Please note that the ICUMSA® Methods numbering system was revised in 2019

Whenever you borrow words or ideas from ICUMSA® Methods or any other ICUMSA® material, you need to acknowledge their source as per the above indicated citation method.

3. Rights to use ICUMSA® Methods

Unless otherwise specified, as owner and publisher, Verlag Dr. Albert Bartens KG ("Verlag Bartens") holds all rights, including copyright in the ICUMSA® Methods, and maintains these rights under all circumstances.
